Managerial Accounting for Managers, 3rd edition – Noreen, Brewer, and Garrison (The companion "Connect" software is not required.)

Course Overview

This course introduces some of the principles, techniques, and processes of managerial accounting. Managerial concepts are largely independent of the "rules based" financial accounting and reporting concepts you learned in your pre-requisite Principles (financial) course. At the same time, proper understanding and application of managerial concepts is *critically important* to internal planning/decision-making/evaluation processes, both short-term and long-range and at multiple organizational levels, in moving an enterprise forward. The ultimate "product" of the collective organizational decisions is the "rules based" financial statements which express the complete financial picture of the organization at any point in time to both internal and external interested parties. In this sense, managerial accounting and financial accounting, while very different in thought processes, are intertwined and work in concert in progressive and successful organizations.

Our focus in this course is *not* "debits and credits" and "journal entries", and we may only on occasion and almost in passing tie managerial and financial accounting together. So, if you did well in your first Principles (financial) course, you have my sincere *Congratulations*, as that *is significant* to your academic experience and in your Accounting or other professional career to follow but don't be complacent and rest on your laurels! Continue to apply yourself in developing your thought processes with this new and exciting track!

It is my desire and goal that the combination of your natural skills and your effort applied, supplemented by whatever I can do to support, encourage, and contribute to your learning experience, will result in:

- your understanding of some basic terminology and methods of managerial accounting.
- your appreciation for the concepts underlying current practices in managerial accounting.
- your ability to effectively apply these concepts to whatever for-profit or not-for-profit enterprise and specific "department" setting you find yourself in at any career stage of your life.
- your ability to effectively apply these concepts for yourself personally, wherever they might be relevant and at any stage of your life.

Class Format

Coverage for each chapter will include a PowerPoint based lecture, working through assigned homework problems, and class discussion. The PowerPoint lecture will be made available on ICON at least one day before the chapter's in-class coverage, and solutions to the assigned homework will also be on ICON after we have completed the in-class coverage.

I do not intend to collect your solutions to the assigned homework. However, you should be prepared to potentially share in class how you approached solving a particular exercise/problem (or parts thereof) even to the point of presenting your complete solution to the class. This expectation serves three purposes:

- "forces" a degree of your attention, in advance, to the assignment for that day.
- encourages dialogue and engagement in the assigned material for the common good.

• minimizes, for your benefit, the monotony of me droning on and on, hour after hour, day after day. Though there is not a defined point value for "class participation" (Course Grade, below), I reserve the right to potentially impact your semester grade in the event of consistent lack of preparation.

Having satisfactorily completed the prerequisites for this course I presume you are well aware of the learning value, and academic performance/result impact, of attempting and working through the homework. Accounting subject matter does not lend itself well to just "read and digest" – effort at working through exercises/problems tends to be for most of us, (perhaps an IQ of 150 or so being an exception) critical to the learning process.

It is *essential* that you have a well-established foundation at the "Principles" level (financial and managerial) for future Accounting courses you might take, and all the more, if that's your objective, for a professional career in Accounting!

Course Grade

The course grade will be based on total points allocated approximately as follows:

Exams

There will be two Exams, with points and chapter overage as previously identified. The Exams will be closed book and closed notes, and will consist of problems as well as possibly short answer essay questions. A basic 4-function calculator will be sufficient for the Exams (as well as for Quizzes). In fact, you can use only a calculator that *does not* have the ability to store text or with communication capabilities. Cell phones and PDA's *cannot* be used for Exams/Quizzes as calculators.

I do not anticipate scheduling a comprehensive final exam – Exam 2 will take place during the scheduled final exam time. However, I reserve the right to include some Exam 1 (i.e. "comprehensive") material on Exam 2 if appropriate and warranted. I will let you know well in advance if this is the case and specifically what material might be eligible.

Quizzes

Quizzes may be either announced or unannounced and will take place on 8 occasions throughout the semester (20 points each). The best 6 of 8 will count, for a maximum accumulation of 120 points counting toward your semester grade. A Quiz can take place on any given class day and at any point during class time, even prior to our lecture coverage for any given chapter. To maximize your semester Quiz points you should come to each class reasonably prepared for that day's expected lecture and/or homework coverage and stay mentally engaged in the information we discuss during our time together. The format described can be considered the "minimum format". There will be at least 160 Quiz points available during the course of the semester, with a maximum accumulation of 120 points. As the semester progresses, this format may be modified to include more Quizzes (and likely for fewer points each) or in other ways. I will let you know in advance of any potential modifications.
