Course Objectives: Enhance your understanding of America's legal systems, improve your critical analysis of current issues, and advance your business problem solving skills.

TEXTBOOK: The Legal Environment of Business, 11th Edition, Roger E. Meiners, Al H. Ringleb, and Frances L. Edwards. Additional reading will be in course packet and online sources.

ACADEMIC INTEGRITY: Students will be held to the highest standards of integrity in completing exams and assignments. If any assignment or exam was not written solely by the student whose name is on it, the student will receive a zero for the assignment or exam and may receive an "F" for the class. The Tippie College of Business Honor Code will determine the appropriate appeal process.

ATTENDANCE AND PREPARATION: You are expected to attend every class fully prepared for that class. Bring your textbook to class every day. This also means all reading assignments and other advance work must be completed as described by the instructor. Absenteeism or lack of preparation will adversely affect your grade. Attendance at all classes and CIMBA sanctioned activities is mandatory. All unexcused absences will have the following consequences:

- a. 1 absence will result in a loss of a ½ letter grade in that class
- b. 2 absences will result in a loss of an entire letter grade in that class
- c. 3 absences will result in a dismissal from the program

Absences due to illness require a note from the CIMBA Staff. If a student is sick and cannot attend class, the student must inform the CIMBA Staff immediately. Failure to do so will result in an unexcused absence.

GRADES: Plus/minus grading will be used. It is expected that final grade distribution will approximate the recommended guidelines of the Management and Organizations Department at the University of Iowa, which is 25% A's, 35% B's, 30% C's, and 10% D's. Such guidelines are only recommendations.
