Course Description:

This course examines the underlying concepts of financial accounting. It reviews the accounting cycle, related accounting records, and the financial statements. Accounting principles and reporting requirements for current assets, plant and equipment, intangibles, and other assets are also studied.

Course Objectives:

This is the first course in a two-semester financial accounting concepts and reporting sequence. The objectives of this course are to:

- Develop an understanding of basic financial accounting concepts and principles
- Enhance problem solving abilities and
- Develop an understanding of the importance of financial reporting to the decision-making of external users.

The majority of this course is devoted to the understanding, recording and reporting of asset and liability items and financial reporting concepts. Emphasis will be on learning and applying accounting principles related to *external financial reporting*. These principles will be put into the context of broader accounting theory.

Course Materials & Resources: Intermediate Accounting, 15th edition by Kieso, Weygandt and Warfield (Wiley).
